February 1<sup>st</sup> marked the 1<sup>st</sup> anniversary of the chapter's "Keep A Candle Burning" campaign. The goal is to keep a single candle burning in your home's window each night to remind our fellow citizens of the individual and family members' sacrifices. These sacrifices are being endured by our active duty personnel and reservists who are in harm's way in Iraq, Afghanistan and elsewhere in the world. The Virginia State Council of VVA endorsed the program, while the program was announced on the floor of the 2007 VVA National Convention.

His family action reflects his twenty years of U.S. Marine Corps service, including two Tours of Duty in Vietnam. Thank you, Byron and Diane.

## JAPANESE-AMERICAN WWII MILITARY SERVICE

Grant Ichikawa will speak at the February 21 membership meeting due to the January meeting weather cancellation. He will speak on his and his fellow Japanese-American military service in WWII and the unjust internment of their families after Pearl Harbor. Japanese-Americans served with exceptional distinction in the Pacific and European Theaters despite a draft status of C-4, enemy aliens, ineligible for the draft. The 442<sup>nd</sup> Regimental Combat Team received 21 Medals of Honor for their European service, and others served as critical interpreters in the Pacific. Marc Leepson's discussion is being rescheduled for a future meeting.

Come early to enjoy a great meal, meet your fellow members, and learn history first hand.

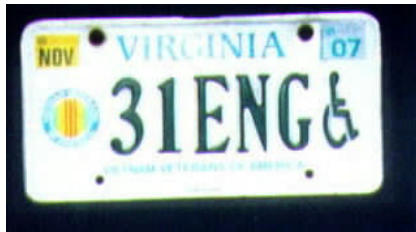
## ELECTIONS 2008 – “A few good veterans are needed!”

## WINTERHAVEN 2008

Len Ignatowski represented the chapter at Winterhaven 2008, a homeless veteran stand down at the D.C. Veterans Hospital on January 12<sup>th</sup>. Two hundred and twenty-six veterans, including eight women received a wide range of services including benefit eligibility, health screenings, dental checks, clothing, a haircut, and a lunch.

Len worked at the clothing distribution station with members from VVA Chapter 641 of Silver Springs, Md. The haircut station appeared to produce the biggest smiles on the veteran faces. Derek Davis, a teacher, and his student barbers from H.D. Woodson High School provided the haircuts. The students demonstrated exceptional skills under the eagle eye of Mr. Davis. Secretary James B. Peeke of VA visited the stand down and shook hands with all the volunteers at the clothing station.

Many kudos is due the excellent hospital staff planning and the team of volunteers from every veteran service that made it happen. The daylong program represented another great example of veterans helping veterans. The chapter has been invited to participate in the 2009 Winterhaven next January.

## DD-214's AVAILABLE ONLINE

The National Personnel Records Center (NPRC) has provided the following website for veterans to gain access to their DD-214's online: <http://vetrecs.archives.gov/>. This may be particularly helpful when a veteran needs a copy of his DD-214 for employment purposes. NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents. Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site.

Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time. Please pass this information on to former military personnel you may know and their dependents. (Source: VVA Chapter 343 Newsletter, February 2008)

## BEWARE OF MILITARY SOLICITATIONS:

The current effort to help our military personnel is generating a tidal wave of veteran assistance scams. At the same time, a journalist investigation into veteran service organizations revealed that the donations are not fully assisting veterans. Legitimate operational and fundraising expenses are part of the business, but make sure that the stated services are being provided at a reasonable cost. Only you can decide what is reasonable, but check it out first!

The chapter is dedicated to minimizing our expenses to insure that we can help when called. For example, the newsletter cost has been gradually reduced due to email delivery and enrollment in a store's rebate program for the printing. 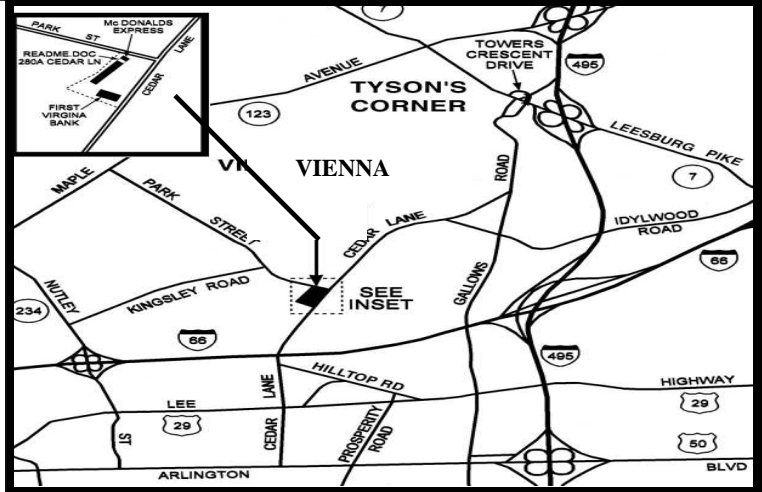
